PROFESSIONAL CREMATION SERVICE OPTIONS

These package prices are effective as of October 21, 2024 and are subject to change without notice.

While the selection of an individualized Cremation may be accomplished through the use of the itemized General Price List, most families we serve indicate a preference for one of the cremation packages listed below. You may add to any of the packages with your choice of merchandise (such as a cremation casket, alternative container, urn, and keepsake jewelry), and cash advanced items (such as health department filing fees, death certificates, obituaries or sales taxes). You may add to any of these plans with other items from the itemized price list.

However no credit can be made for substitutions or deletions from the funeral service packages.

Basic Cremation\* (10-14 day turnaround from date disposition permit is filed)
